

CPAC TROUPE AUDITIONS (*Ages 6-9)

Age is determined as of January 1, 2019

**Dancers older than 9 as of this date must audition for Ensemble (Spring) or CPAC Rec (August)*

(Wear comfortable dance clothes – bring Tap shoes – dance barefoot for Jazz)

Registration Deadline: April 16, 2018

**This program is designed to prepare dancers for the Competitive Ensemble Group at CPAC.*

**ALL dancers must audition each year for Troupe consideration.*

**IF you wish to audition for Ensemble in addition to Troupe, you must register separately*

Troupe Requirements

- Attendance REQUIRED August 6-10 to learn choreography – no exceptions!
- Attendance REQUIRED June 5-14 Tues/Wed/Thurs – Ballet, Jazz, Tap (90 min/day)
- 2 competition routines (Jazz & Tap)
- Fall 2018-Winter 2019 Weekly Class Attendance – 2 nights per week
 - Ballet, Tap, Jazz class required plus rehearsals of competition routines
- Attend 2 out of town competitions per year (typically KC and STL)
- No national competitions, no required conventions
- No need for online registration – class placement automatic
- Account balances must be paid in full prior to auditions
- Troupe members must dance solely at CPAC – no other Columbia studios

Fee Summary (approximately \$1375/year)

- Class Tuition Cap = \$550 (20% discount if paid in full by end of August)
 - Take any non-Troupe classes at no extra charge (level must be approved by CPAC office)
- June CPAC Workshop Tuition = \$75
- Choreography Fees – 2 dances = \$350
- Competition Team Jacket = \$60
- Competition Costumes – 2 dances = \$150
- Entry Fees – 2 dances at 2 competitions = \$180

- Tuition \$620 per year
- Conventions PLUS competitions (approx \$300-\$1200)
- Possible out of state travel
- 3 nights of class per week (class length approx 90 min each)
- June class requirement (approx \$75)
- Estimated cost per group routine \$675

GENERAL INFORMATION:

- I understand that this program is designed to prepare dancers for the Competitive Ensemble Group at CPAC.
- I understand that if selected my dancer must train solely at CPAC for the 2018-2019 season.
- I understand that this is a selective process and that it is possible that some dancers may not be chosen to participate in this program.
- I understand that any dancer age 10 or older (as of January 1, 2019 who is not moved up to the Ensemble) will be ineligible to participate in the Troupe program.
- I understand that my dancer must audition each year if they wish to continue participation. Dancers may or may not make the team each year. Prior participation has no guarantees.
- I understand that if selected I am required to attend classes June 5-14 (Tues/Wed/Thurs).
- I understand that if selected I am required to attend all scheduled choreography sessions August 6-10, 2018.
- I acknowledge child's participation in CPAC classes exposes child to risks of personal injuries because it involves physical exertion that may cause injury. I choose for Child to participate in classes and voluntarily assume all risks of activities occurring while child is participating. I promise not to sue CPAC and discharge and release CPAC, its employees, officers, agents from all claims for any or all personal injuries/damages to Child arising from child's participation in the classes.
