

# 2019-2020 "TROUPE" AUDITION INFORMATION (\*Ages 6-9)

\*Must be age 6 as of AUGUST 1, 2019 or \*Not older than age 9 as of JANUARY 1, 2020

Dancers younger than age 6 as of August 1, 2019 may audition for MiniTroop

Dancers aged 9 or older as of January 1, 2020 may audition for Ensemble (Spring) OR Collective (August)

(Wear comfortable dance clothes, bring BALLET & TAP SHOES. Jazz will dance barefoot. Hair securely pulled back, out of face)

\*This program is designed to prepare dancers for the Ensemble Group at CPAC.

\*ALL dancers must audition each year for Troupe consideration.

Technical skills

Performance skills

Mental focus

Maturity

Appropriate classroom behavior

# **BEFORE YOU AUDITION!....**

- August 5-8 & August 12-15 required
- September weekends required (schedule TBA in June)
- Annual cost is approximately \$1400
- Review the Absences policy
- If given the opportunity, will you participate on the team?

\*If any of these are a problem, please do not audition, as you are potentially taking someone else's place on the team.

# WHAT TO EXPECT!.....

- Selection of the competition team members is through an audition process.
- Some of those who audition will not make the team.
  - o We trust that parents will properly prepare their dancers for this possibility.
- Criteria to be evaluated at auditions are listed above.
- Announcement of the 2019-2020 Troupe team will be made via EMAIL the week of May 20th after Spring Recital (prior to online Fall registration).
- We assume everyone who makes the team will accept the invitation to be part of the Troupe team for 2018-2019.
  - You have until Tuesday May 28th to decline participation.
  - o Keep in mind IF you decline, you will have to register on your own for classes.

# Competition Fees 2019-2020 Season

(all fees are payable directly to CPAC)

- Estimated Costs approximately \$1400/year (payment plans available)
  - Choreography Fees for 2 Dances = \$350
  - Class Tuition = \$550
    - (20% Discount if paid in full by the end of August)
  - August Workshop (August 5-8 & August 12-15) Required = \$100
  - Competition Team Jacket = \$60
  - Competition Costumes for 2 dances = \$150
  - Entry Fees for 2 dances at 2 competitions = \$180
- Payment Deadlines for the 2019-2020 season are as follows:
  - August 5, 2019 August Workshop fee due
  - August 30, 2019 Tuition discount deadline
  - o September 3, 2019 ½ of group choreography rehearsals fees due
  - October 1, 2019 remaining choreography fees due
  - $\circ$  December 2, 2019  $\frac{1}{2}$  of competition costume fees due
  - February 3, 2020 remaining competition costume fees due
  - March April 2020 Entry fees for competitions are due TBD

### **Competition Requirements and General Information**

- All accounts must be paid in full in order for your child to audition for competition. If chosen, you
  will be placed in two competition routines.
- Troupe members commit to train solely at CPAC. You are not permitted to take classes at any
  other studio in Columbia while you are on the competition team.
- Attendance REQUIRED September weekends to learn choreography no exceptions! Specific schedules will be announced in June.
- Attendance REQUIRED <u>daily</u> August 5-8 & August 12-15 for Troupe Ballet, Jazz, and Tap Classes (4:15-5:45pm)
- Fall 2018-Winter 2019 Weekly Attendance 2 nights per week (likely Tuesday & Thursday)
  - o Ballet, Jazz, Tap class required plus rehearsals of competition routines
- 30-minute weekly competition rehearsals will begin the week of September 3rd. There will likely
  be additional rehearsals throughout the fall/spring as needed to prepare dancers for the
  upcoming season. As much notice as possible will be provided.
- <u>ABSENCES</u>: Only 3 total absences are allowed from classes and rehearsals regardless of the reason (this includes illness, school functions, etc) – absences start tracking the week of September 3<sup>rd</sup>.
  - Classes are just as important as rehearsals! Attendance each day is all or nothing, meaning that if you will miss class, you must also miss rehearsal (and vice versa).
  - o Absences in excess of this policy may result in removal from the dance.
  - If you are removed from a competition piece due to absences or if you voluntarily leave a competition number <u>after May 28th</u>, there will be <u>no refunds</u> given for fees already paid or billed including costumes, entry fees, choreography or rehearsal fees.
- Troupe yearly class tuition will be capped at \$550 per child if you pay your tuition in full no later than August 30th, you make take advantage of a 20% discount, paying only \$440.
- No need for online registration class placement automatic.
- Attend 2 out of town competitions per year (typically KC and STL). Competition dates will be provided in the Fall for the 2020 season so please plan accordingly.
- No national competitions, no required conventions
- You must be able to perform in the Competition Showcase (CPAC Theatre) in the Spring.
- You must be available to perform in all Spring Recital performances IF your competition number is selected to perform. Troupe routines may or may not perform in Spring Recitals.
- Competition warm-up jackets are required. These should be worn as a cover up while at competitions. Estimated cost is approximately \$60 per jacket.

- My child's participation in CPAC classes exposes child to risks of personal injuries because it
  involves physical exertion that may cause injury. I choose for Child to participate in classes and
  voluntarily assume all risks of activities occurring while child is participating. I promise not to sue
  CPAC and discharge and release CPAC, its employees, officers, agents from all claims for any or
  all personal injuries/damages to Child arising from child's participation in the classes.
